ORDER

Having read the stipulation of the parties, and finding that good cause exists, it is hereby ordered that:

1. *Weaver v. Hallmark Marketing Corporation*, Case No. CV08-07481 VBF (Ex), shall be consolidated with the *Ingalls v. Hallmark Marketing Corporation* and *Fuzell v. Hallmark Marketing Corporation* actions, based on this Notice of Settlement;
